	<p>Washington School Heritage Foundation President James Beckstrom gave insight on how the foundation has been engaged in strategic planning. The focus areas are operational strategy and engagement with strategic partners, including City of Stillwater, Oklahoma State University, Stillwater Public Schools, Oklahoma Historical Society, the Oklahoma African American Educators Hall of Fame, Stillwater Public Library, and Stillwater History Museum. A recurring topic within the Foundation is the need to formalize the relationship between the Foundation and the City of Stillwater. Beckstrom provided an update on the Foundation’s conversations with a roofing supplier. A general contractor has volunteered their time to manage the project at no cost.</p>
c.	<p>Discussion and possible action for next steps in the redevelopment process of Washington School.</p> <p>DCM Driskel shared that Chair Washington has reported OSU requested access to measure the faux fireplace, carpet, and curtains so they could be removed to allow for wall repair work. McNickle questioned if the bill has been received for the final demolition sodding. DCM Driskel stated the invoices are still coming in due to the dirt work. Once those invoices are received, action will be taken with City Council to redeposit the funds into the Tourism Advisory Account. Arata is completing the historical marker application to submit to the Oklahoma Historical Society, which will fund and install the historical marker. Beckstrom discussed covering the gymnasium windows for the benefit of keeping animals out. He raised a concern about not having natural light or airflow in the gymnasium. The committee agreed to leave the windows as they are for now.</p>
